KITTEN MILESTONE & STORE READY CHECKLIST

2 Weeks Old

- Due for 1st Dewormer – Signup for a Wellness Appointment [{click here}](#) or email RoutineMedical@houstonpetsalive.org

4 Weeks Old

- Due for 2nd Dewormer – Signup for a Wellness Appointment [{click here}](#) or email RoutineMedical@houstonpetsalive.org
- Kittens should be ready to wean onto gruel -- be sure to weigh kittens daily and log weight gains

6 Weeks Old **AND** 1 ½ Pounds (680 grams)

- Due for wellness check – Signup for a Wellness Appointment [{click here}](#) or email RoutineMedical@houstonpetsalive.org
 - ___ 1st FVRCP vaccine
 - ___ 3rd Dewormer
 - ___ Flea Meds
- Kittens should be eating independently

8 Weeks Old **AND** 2 Pounds (907 grams)

- Due for wellness check - Signup for a Wellness Appointment [{click here}](#) or email RoutineMedical@houstonpetsalive.org or coordinate for check during surgery
 - ___ 2nd FVRCP vaccine
 - ___ 4th de-wormer
 - ___ Felv/FIV Combo Test
 - ___ Microchip
- Schedule for Spay/Neuter surgery, when 2lbs & healthy – email RoutineMedical@houstonpetsalive.org or [{click here}](#)
- Photos and bios due the week of surgery – email bios@houstonpetsalive.org and petstorecats@houstonpetsalive.org
- Viewable under “Adoptable Cats” on the website after completion of surgery
- Request a spot for your kittens in the pet store
- Eligible for entrance to Pet Stores ONLY IF THE ABOVE MEDICAL HAS BEEN COMPLETED!! See next page for Store Ready Checklist including foster evaluation.

10 Weeks Old if still in Foster Care

- Due for wellness check - Signup for a Wellness Appointment [{click here}](#) or email RoutineMedical@houstonpetsalive.org
 - 3rd FVRCP vaccine
 - 5th de-wormer

12 Weeks Old if still in Foster Care

- Due for wellness check - email RoutineMedical@houstonpetsalive.org
 - 4th (final) FVRCP booster
 - Rabies vaccine

Ready to Go to the Pet Store?

Kittens must have the following medical treatments completed:

- FVRCP #1
- Deworming #3 (#1 if kittens were taken in after 4 weeks old)
- Flea Meds
- FVRCP #2
- Deworming #4 (#2 if kittens were taken in after 4 weeks old)
- Felv/FIV Test (completed on day of surgery)
- Microchip (completed on day of surgery)
- Spay/Neutered

Kittens should be evaluated by Foster for the following:

- No fleas AND up-to-date on flea meds
- No sneezing or eye discharge
- No missing fur
- Has solid fecal
- Has clean ears
- Is eating dry food
- Is spayed or neutered as listed
- Is up-to-date on age appropriate vaccines
