We locate and place each animal into a foster home and then provide events for the fosters to bring adoptable animals to. We take care of each animal - providing all medical services from intake through adoption.

Spay/Neuter - We have a medical clinic that provides medical services to the dogs and cats taken in to our program. We have 2-3 vet technicians on staff, and we have a part time contract veterinarian that performs spay/neuter services three times a week. We provide all vaccines, anesthesia and other medical treatment for each of the dogs and cats in our program.
